## **Food Protection Manager Certification**

Allegheny County Food Safety Regulations require that a Certified Food Protection Manager be present in a food facility at all times food is being prepared or handled. The owner or operator of the food facility is responsible to ensure that they have enough people on staff certified as Food Protection managers to meet this requirement.
