On May 24th, 2018, Officer Vojtas was confronted by an inmate with a deadly weapon who threatened to

assault him. Officer Vojtas deflected the weapon and activated an alarm, causing the inmate to retreat to his cell where he held his --- where he held his cellmate at knifepoint.

Captain Terry, who responded to Officer Vojtas' call for assistance, was able to calm the hostile inmate and talk him into surrendering his weapon. Because of these actions of Officer Vojtas and Captain Terry, situation resulted in the inmate surrendering without any injuries to inmates or staff.

(Applause.) OFFICER VOJTAS: I'd like to say for City Council, thank you very much for this opportunity. I know, as an officer, we do have a stressful job but it's our duties to take into consideration that we, every day, have the initiative to protect the inmates along with the staff members and you have a --- a job to do with making sure everybody's, you know, safe, and so on and so forth for the, you know, the jobs that we do. It's a stressful day and, you know, it could be dangerous but we know what we take into consideration that, you know --- you know, we got a job to do. And I'd like to just thank all my --- my staff members as well --- can't --- can't be more thankful. Thank you.

On July 27th, 2018, while conducting a routine cell search, Officer Marzano was attacked by two immates of deadly weapons and was injured. Officer Paul possessing deadly weapons and was injured. Officer Par Romanelli rushed to assist him and was assaulted and wounded. Sergeant Coulter, meanwhile, locked down the pod, requested additional assistance and rushed to help the injured officers. One hostile inmate fled to his cell and attempted to rid himself of a weapon. Sergeant Coulter subdued and held the inmate while also maintaining visual sight of the weapon, keeping other inmates from --until additional officers arrived. The actions of Officer Marzano, Officer Romanelli and Sergeant Coulter protected other officers from further assault by ending the incident quickly with the inmates back in confinement.
