# RESOLUTION 3 OF 2024 TO THE BOARD OF ELECTIONS OF ALLEGHENY COUNTY, PENNSYLVANIA REGARDING SATELLITE VOTING LOCATIONS

**WHEREAS**, Pennsylvania law permits the Allegheny County Board of Elections, through its Division of Elections, to have multiple locations for the operation and conduct of election matters throughout Allegheny County and further provides for satellite election offices, and

WHEREAS, the Allegheny County Division of Elections, in conjunction with the Department of Administrative Services and the Department of Information Technology, has conducted due diligence and developed a plan to provide for additional locations for five regional staffed satellite elections offices where voters can apply, receive, vote, and return their mail-in and absentee ballots; and

WHEREAS, the Allegheny County Board of Elections finds that adoption of the plan to provide for additional Elections Division locations is necessary to make voter participation in elections more convenient and secure for the electorate of Allegheny County.

**NOW, THEREFORE, BE IT RESOLVED** by the Allegheny County Board of Elections as follows:

To make voting accessible, convenient, and safe as possible, the Elections Division shall provide for staffed satellite elections offices at five locations within the county. For the 2024 General Election the following satellite locations, their dates and hours of operation listed below:

Tuesday, Wednesday and Thursday, October 15<sup>th</sup>, 16<sup>th</sup> and 17<sup>th</sup>. Hours: 8:00 AM to 4:00 PM

The Division shall timely submit the above-described plan to the Department of State for approval as suggested but not required by Department of State guidance.

The Division of Elections shall continue to provide for over the counter voting and ballot return at the County Office Building lobby, during regular business hours-8:30 to 4:30 Monday thru Friday, as soon as ballots are available.

The Division of Elections shall post hours of operations of the satellite election offices on its website and through other means consistent with Department of State Guidance.
