## **Animal Specimens for Rabies Testing**

#### **Test Description**

Rabies testing is a qualitative assay which samples submitted animal brain tissue. Direct fluorescent antibody staining it utilized to identify the presence of the rabies virus.

Specimens should be taken to the Public Health Laboratory in Lawrenceville, located at 3901 Penn Avenue, 15224 to Building 8 or Building 1 (schedule below):

#### Standard Hours

#### Acceptable Specimens: collection guide and transport conditions

- Brain tissue
  - o <u>Temperature</u>: Refrigerated (2-8 °C) Frozen (-5 and beyond)
  - Container: Small specimens can be submitted in their entirety. Larger animals must be decapitated and only the head submitted

- Anything greater than 30 lbs., it is considered a large specimen and will need to be decapitated for submission and testing
- Notes: Specimens cannot be submitted if there is significant damage to the brain as this will preclude testing. Specimens, with exception of bats, should be euthanized before delivery

- Animals brain must not be damaged to the point that brain tissue cannot be retrieved
- All animals other than bats must not be received alive. If the animal is alive at
  the time of submission, the laboratory will insist that it be taken to a
  veterinarian's office (or other acceptable agency) to be euthanized
- Submitted animals must possess an intact head
- Specimens cannot be fixed in formalin
