Approach (25 points)

1. Describe your organization's proposed intervention, including the services that will be provided and the intended outcomes. (10 points)

Sisters Place proposes to expand our existing harm reduction and wellness services to support better those impacted by opioid and other substance use disorders in our community. Existing staff will provide non-judgmental support and connections to treatment and recovery services for those who visit our Safe Space community walk-in program.

Staff will also lead support groups and social activities to reduce isolation and build community among those in recovery. Educational workshops on overdose prevention and reversal, safer drug use practices, and navigating recovery will be provided.

We will continue providing harm reduction supplies like naloxone, fentanyl test strips, male/female condoms, and safe sharps disposal. The intended outcomes are to reduce overdose deaths, transmission of infectious diseases, and high-risk drug use behaviors. By building trust and meeting people where they are with compassion, we aim to encourage treatment readiness so more people find the support needed to achieve greater health and wellness.

Our goals are to:

- Engage with the community more through informational outreach mailing(s) in the 15210 postal zip code area.
- Increase individual attendance in our Safe Space Program.
- Increase dispersion of naloxone, fentanyl test strips, and male/female condoms.
- Increase offering of opioid and substance use support groups, social activities, and educational workshops.

By leading with empathy instead of judgment, we can help save lives in our community.

2. Which focus community(ies) and population(s) does your organization plan to serve? Explain how this community and population have been disproportionately impacted by the opioid epidemic. (15 points)

Sisters Place services individuals and families in need of support, especially the South Pittsburgh, Hilltop Area, including the disproportionately affected communities of Carrick, Knoxville, and Mt. Oliver.

The Hilltop Area of Pittsburgh, including Carrick, Knoxville, and Mt. Oliver, has been hit especially hard by the opioid epidemic compared to other areas of Allegheny County and Pennsylvania. This region has high poverty rates, limited economic opportunities, and a shortage of accessible treatment and recovery services.

Many residents of these neighborhoods work blue-collar, physically demanding jobs where workplace injuries are common. This can lead to initial prescription opioid use spiraling into misuse and addiction. At the same time, mental health challenges stemming from generational poverty, trauma, and despair have also contributed to residents self-medicating with substances.

According to county overdose data, fatal overdoses in this zip code are approximately three times higher than in Allegheny County overall. The population lacks resources to obtain naloxone and other harm reduction tools. There is also a strong stigma against substance use disorders in the community, presenting barriers to seeking help.

By serving Carrick, Knoxville, and Mt. Oliver residents with compassion free from judgment, Sisters Place aims to save lives in a population that has endured disproportionate harm from the opioid crisis. Our culturally competent services will promote healing and resiliency in a vulnerable community.

Community Designed and Operated (45 points)

3. Explain how your organization's proposed intervention will be community designed and operated, including a plan to include community members in the planning, design and/or implementation of the intervention. (15 points)

Sisters Place is committed to ensuring our proposed opioid intervention is community-designed and led. Our organization has deep connections to the impacted neighborhoods of Carrick, Knoxville, and Mt. Oliver – and all of the Hilltop. Many of our staff members and/or their loved ones have lived experience with opioid and substance use disorders, including our CEO Melissa Ferraro, who grew up in these communities.

This personal understanding fuels our passion to meet the needs of this population with compassion. However, we recognize that every experience is as unique as the individual, and we will need to gather much feedback from the community when considering solutions. We will consult our Community Advisory Board to help guide the program's policies and direction. We will collaborate to provide services and promote healing by making space for local insights. We intend to support this marginalized but resilient population to write their own hope and recovery story.

4. Explain why your organization is the appropriate provider to implement the proposed intervention, including a description of your organization's experience providing support or services to, with, or within communities that have been disproportionately affected by the opioid epidemic. (15 points)

Sisters Place has proudly served marginalized communities in Allegheny County for over 30 years. While our proposed opioid intervention may be smaller in scale compared to other applicants, it will be genuinely transformative for the underserved neighborhoods we have long partnered with.

Few issues have wreaked more havoc in these communities than the opioid epidemic. We have witnessed the devastation caused, from lost lives to derailed dreams. However, we have also seen incredible resilience among those overcoming their addictions. Implementing this targeted outreach can help save lives and provide hope to those who need it most.

Our experience operating within the Carrick, Knoxville, and Mt. Oliver neighborhoods makes Sisters Place uniquely qualified to lead this work. We have built trust and

understanding that outside organizations would struggle to establish. Our staff's personal connection to opioid and substance use challenges helps us approach this stigma-laden issue with the deep compassion and cultural competence it demands.

For decades, we have walked closely with vulnerable community members struggling with poverty, homelessness, and despair. Expanding our harm reduction and support services is the logical next step to address an unrelenting problem.

Sisters Place is committed to diversity, equity, and inclusion in our staffing. We aim to hire team members who reflect our communities, especially Black individuals and those in recovery who can provide culturally competent care.

Rather than adding new positions, we will expand the roles of existing staff to deliver the proposed opioid intervention. This avoids instability when one-time grant funding ends. The Community Resource Coordinator vacancy provides direct services to those seeking substance use support. We are actively recruiting Black candidates with lived experience.

All Sisters Place staff receive robust training on harm reduction, trauma-informed care, and naloxone administration. Staff bring experience and specialized training to meet this population's unique needs. With deep community roots and relevant professional development, our diverse staff have the qualifications and passion to lead this work.

By investing in the professional growth of our existing team versus adding short-term hires, we aim to sustain services beyond the initial grant period. Our plan ensures continuity for the vulnerable people we serve while reflecting our diversity and inclusion values. We believe this staffing approach will lead to the greatest long-term impact.

Sisters Place requests \$75,000 to expand our harm reduction services for those impacted by opioid and substance use disorder provided in the South Pittsburgh, Hilltop Area of Pittsburgh, including the disproportionately affected communities of Carrick, Knoxville, and Mt. Oliver.

The budget breakdown is as follows:

- \$30,000 towards staff salary and benefits:
 - \$15,000 for the Community Resource Coordinator providing prevention, education, and support through direct outreach, engagement, and warm handoffs to treatment.
 - \$10,000 for the Director of Engagement & Programming to supervise the Community Resource Coordinator and coordinate community events.
 - \$5,000 for the CEO to provide leadership and serve as the public face of this
 effort.
- \$25,000 for unrestricted general operating expenses to sustain Sisters Place's location, staffing, and vital community services.
- \$10,000 for printed outreach materials and postage, including informational postcards
 mailed to 15210 zip code residents on accessing opioid and substance use disorder
 services at Sisters Place and other resources.
- \$10,000 for expenses related to support groups, social activities, and educational
 workshops on overdose prevention and reversal, safer drug use practices, and navigating
 recovery.

This budget allows us to expand direct outreach under solid leadership when and where it is most needed. It provides critical supplies and resources to make meaningful connections to treatment and recovery. We aim to maximize impact within the modest budget by focusing funds on frontline engagement, leadership, evaluation, and flexibility to address emergent needs.
