## Your Baby's Growing

You know your baby best. You are watching all the amazing things baby is doing every day. You can visit the PA Promise for Children website at <a href="https://www.connectpa.net">www.connectpa.net</a> to see what to expect now and in the future as your baby learns more about the world and how to respond to it.

The Commonwealth of Pennsylvania is committed to making sure that eligible newborns and young children, up to age five years, have the support they need to reach their developmental milestones.

In Allegheny County, we do this by working with the child and their caregiver(s) early in the child's life.

The Allegheny County Department of Human Services Office of Behavioral Health (OBH) contracts with The Alliance for Infants and Toddlers to provide assessments and evaluations and developmental monitoring of infants and toddlers up to three years of age.

## **Early Intervention**

Early intervention (EI) services are provided to infants and children up to three years of age who

- have a delay in one or more areas of development such as: how they crawl, walk or stand, how they reach and play with toys and other objects, how they let you know what they need and how they interact with others.
- have a diagnosis or condition that is very likely to lead to a developmental delay
- are determined to be eligible based on the professional opinion of a trained clinician

EI services are provided by trained professionals and take place most often in the child's natural environment and involve the young child and the caregiver(s). Services are customized for each child and build on the child's strengths; always working toward improvement.

### **Developmental Monitoring**

Infants and young children who are at *risk* for developmental delay are eligible for developmental monitoring, also known as At-Risk Tracking. They include

- > children who weighed under 3 lbs. 5 oz. at birth (1500 grams);
- children who were cared for in a Neonatal Intensive Care Unit following birth;
- children who were born to a chemically dependent mother;
- children who are involved with the Office of Children, Youth and Families; (CYF) due to serious abuse or neglect
- confirmed dangerous levels of lead poisoning as set by the Department of Health;
- children who are experiencing homelessness;

# How to Find Out If Your Child Qualifies

All young children who live in Allegheny County qualify for a multi-disciplinary evaluation even if they do not fall into any of the categories mentioned earlier.

If you believe your young child, under three years of age, may be eligible for early intervention or developmental monitoring, simply call The Alliance for Infants and Toddlers at 412-885-6000 to make an appointment to have your child evaluated.

# El Services for Children Three to Five Years of Age

Your preschooler may be eligible for early intervention preschool services, whether or not they received EI services before the age of three years.

These services are most often provided in a pre-Kindergarten classroom or other community setting.

If you live within the City of Pittsburgh, please call Pittsburgh Public School District at 412-529-4000 to schedule a screening for your child.

If you live within Allegheny County but outside the City of Pittsburgh, please call the Allegheny Intermediate Unit at 412-394-5904 to schedule a screening for your child.
