### Allegheny County Health Department – Air Quality Program – Clean Air Fund Application Electrification of Municipal Equipment 2024

The following is a request for application to electrify municipal equipment within Allegheny County, PA.

This funding should be used to either replace diesel or gasoline fueled equipment. Funds may also be used for administrative costs, staff training, equipment, and supplies if needed.

**Grant amount:** Minimum award requested must be \$10,000. The maximum award for an individual project will be no more than \$75,000. It is expected that no more than six grants will be awarded.

Eligible entities: Municipal governments and their respective Councils of Government in Allegheny County, PA.

**Projects that will be considered:** The ACHD will only consider projects located in and benefiting the residents of Allegheny County. Priority will be given to projects within Environmental Justice communities with top priority given to those projects located in the Monongahela Valley. Projects must support activities related to the improvement of air quality within Allegheny County as allowed by Article XXI §2109.09.c.1.G. Projects must replace diesel or gas-fueled municipal equipment with zero-emission equivalents including but not limited to lawnmowers, weedwhackers, snowplows, and stump grinders.
