Instructions & Conditions

The free membership pass is valid ONLY for **Active Volunteer** Firefighters and Emergency Medical Technicians who reside in Allegheny County. The pass provides free admission to Allegheny County's pools, ice skating rinks, and ski slope facilities (not valid for snow tubing). Approved applicants may pick up a barcoded membership pass from any park office, pool, or skating facility during business hours. *All volunteer memberships expire 365 days from the date of approval. It is the volunteer's responsibility to renew membership annually.*

The membership pass must be presented upon entering the facilities - individuals will not be admitted without a valid membership pass. A fee of \$5.00 will be charged to replace a lost or stolen pass. Lending a pass will result in revocation of membership privileges. The applicant for the Active Volunteer Firefighter & Emergency Medical Technician Membership Pass understands and agrees to abide by all rules and regulations of the Parks facilities. Allegheny County Parks Membership Pass Waiver

PLEASE READ THE FOLLOWING WAIVER CAREFULLY, AS IT AFFECTS YOUR FUTURE LEGAL RIGHTS BY PROCEEDING WITH REGISTERING FOR THE RECREATIONAL AND FITNESS ACTIVITIES AS PART OF THIS COUNTY PROGRAM, YOU ACKNOWLEDGE AND AGREE THAT YOU HAVE CAREFULLY READ AND FULLY UNDERSTOOD THE WAIVER AND AGREE TO THE TERMS SET FORTH BELOW

1. I fully understand and acknowledge that: (a) recreational and fitness activities have inherent risks, dangers, and hazards and such risks, dangers and hazards exist in the use of any equipment and the participation in these activities; (b) both my own and my minor child(ren)'s participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to, bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that, could cause serious disabilities; (c) these risks, dangers, and hazards also may be caused by the negligence of the agents, officers, representatives, employees, or volunteers of Allegheny County, the Allegheny County Parks Department, the negligence of the participants, the negligence of others, accidents, breaches of contract, or other causes.
2. In consideration of the acceptance of registration and/or the registration of my minor children in the recreation and fitness activities encompassed by the County program and my participation in these activities and my and my child(ren)'s use of the equipment, and intending to be legally bound thereby, I (and also on behalf of my minor child(ren)) voluntarily assume all risks and danger and all responsibilities for any injuries, losses, and/or damages of any kind whatsoever, whether caused in whole or in part by the negligence or the conduct of the agents, officers, representatives, employees, or volunteers of the Allegheny County and the Allegheny County Parks Department, or by another person.
3. I, on behalf of myself, my minor child(ren), my personal representatives and my heirs, executors, and administrators, hereby voluntarily agree to release, waive, discharge, hold harmless, defend, and indemnify the Allegheny County, the Allegheny County Parks Department and their agents, officers, representatives, employees, and volunteers from any and all demands, claims, causes of action, liability, or losses for bodily injury, property damage, wrongful death, loss of service or otherwise which may arise from any cause whatsoever and including those arising in any way from my or my minor child(ren)'s use of any equipment or participation in these activities. I specifically understand that I am releasing, discharging, and waiving any demands, claims, or causes of causes of action that I or my minor child(ren) (or my above-stated representatives) may have presently or may have in the future for the negligent acts of other conduct by the agents, officers representatives, employees, and volunteers of the Allegheny County and the Allegheny County Parks Department.

BY SIGNING THIS APPLICATION WAIVER, I UNDERSTAND THAT I AM GIVING UP SUBSTANTIAL RIGHTS, INCLUDING THE RIGHT TO SUE. I ACKNOWLEDGE THAT I AM AGREEING TO THIS WAIVER FREELY AND VOLUNTARILY, AND THAT I INTEND BY THIS WAIVER TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
