20	<p>According to Section 2105.61 (a & b) of Article XXI, Rules and Regulations of the Allegheny County Health Department, Air Quality Programs, all persons engaged in the removal or encapsulation of friable asbestos containing material must have successfully completed an asbestos health and safety training course within the previous twelve (12) month period. The training course must be fully accredited by the Environmental Protection Agency in accordance with either the asbestos abatement worker or asbestos abatement supervisor accreditation requirement, whichever is applicable of the EPA Model Accreditation Plan (40 CFR 763, Subpart E, F & G, ¶ 763.80 et seq. And appendices, and the PA Asbestos Occupation Accreditation and Certification ACT (63 PS ¶ 2104 & 2105) Appendix C). Provide evidence of this training by enclosing a copy of the employee's PA Asbestos</p>

Certification License. <i>Provide as well, a copy of the PA DOLI License for individual contractor and your company.</i>

Provide a copy of your written standard operating procedures and employee protection plans implemented by all your employees engaged in asbestos abatement activity. Include specific reference to OSHA medical monitoring and respirator training programs. Provide appropriate documentation of employee participation in these plans.
