Health Department Announces 12 New Food Establishments in January

PITTSBURGH – Licenses were issued to 12 new food establishments in January, the Allegheny County Health Department (ACHD) announced. The new establishments include seven restaurants, a confectionary, a bakery, one fitness center eating area, a juice bar, and one grocery store.

“We are pleased to report that half of the new food establishments that were licensed in January will be using trans-fat-free cooking oils,” said Health Department Director, Dr. Karen Hacker. “As part of our county-wide commitment to promoting individual and community wellness, we highlight the facilities that use the healthiest cooking methods, and we encourage all eateries to provide the healthiest possible food options for its patrons.”
