Health Department Announces 13 New Food Establishments in February

PITTSBURGH – Licenses were issued to 13 new food establishments in February, the Allegheny County Health Department (ACHD) announced. The new establishments include 10 restaurants, one juice bar, one bakery, and one tea house.

Out of the 13 new establishments, 10 will be using trans-fat-free cooking oils.

“As part of our county-wide commitment to promoting individual and community wellness, we highlight the facilities that use the healthiest cooking methods,” said, Dr. Karen Hacker, ACHD Director. “We are very pleased to see a large amount of new food establishments in the county that are using trans-fat-free cooking oils, and we encourage all eateries to provide the healthiest possible food options for its patrons in the future.”
