Thirteen New Food Establishments Licensed in September in County

PITTSBURGH – The Allegheny County Health Department (ACHD) announced that it issued licenses to 13 new food establishments in the county in September. The establishments include seven restaurants, a bakery, one convenience store, one craft brewery, a home goods store, a private club and one confectionary.

“We are excited to announce this new group of food establishments that opened across Allegheny County last month,” said Health Department Director, Dr. Karen Hacker. “One of the first steps to *Live Well* is to eat healthier foods, particularly those that have more good fats than bad fats, or trans fats. As part of our county-wide commitment to promoting individual and community wellness, we highlight the facilities that use the healthiest cooking methods, and we encourage all eateries to provide the healthiest possible food options for its patrons.”
